## NON-DISCLOSURE AND NON-CIRCUMVENTION AGREEMENT

### NON-DISCLOSURE OF INFORMATION:

The undersigned Buyers' acknowledge that they are principle(s) Buyer(s) in this transaction and that the Seller of the subject business desires to maintain the confidentiality of the information disclosed.
